- ilaalinta kireystayaasha in lagu qoro keydka kireysiga la habsaamey kirada ee ay sababtey saamaynta COVID-19
- xaddidaya kharashyada dib-u-soo-celinta ee kireystayaasha u-qalma ee horay u joojiya heshiiska kirada muddada go'an
- kordhinta bayaanka kirada mudada gaaban ee guryaha la guuri karo
- xaddidaadda gelitaanka iyo shuruudaha lagu taageerayo tallaabooyinka kala fogaynta bulshada ee COVID-19

24-kii Abriil 2020, Xukuumadda Queensland waxay hirgelisay tallaabooyin kala duwan oo looga jawaabay xaaladda degdegga ah ee COVID-19 si loo bixiyo ilaalin wanaagsan iyo in la taageero xasilloonida suuqa kirada ee Queensland, oo ay ka mid yihiin:

- **hakad lix bilood ah ka saarid guri** oo loogu talagalay COVID-19 kiro baaqasho ah inta udhaxeysa 29 Maarso iyo 29 Sebtember 2020
- **kahortaga liistada keydka macluumaadka kireysiga** ee kireystayaasha leh kirooyinka COVID-19 ee lal raagey
- **kordhinta heshiisyada kireysiga muddada go'an** ee lala leeyahay COVID-19 kiraystayaasha saamaynta ku leh 30 Sebtember 2020 illaa kiraystuhu codsado muddo gaaban
- **ka hortagga milkiileyaasha guryaha inay joojiyaan heshiisyada** ee lala galo COVID-19 kiraystayaasha ay saamaynta ku yeeshen iyadoon wax sabab ah la siinin iyo in la siiyo sababo cusub oo la oggolaaday oo dhinacyada ay ku joojinayaan heshiisyada
- **kireystayaasha la kulma rabshadaha qoyska iyo qoyska** waxay joojin karaan xiisaha ay u qabaan kireysiga si deg deg ah iyaga oo leh mas'uuliyad xadidan dhamaadka heshiiska kirada
